Minutes of the BEC meeting, December 19, 2024



Treasurer Al Wuthnow gave treasurer's report which showed balance at end of November as \$7,181. We had 80+ members and guests at the December lunch but were \$175 short on amounts collected to cover the costs. Three members were no-shows which had paid to sign up. The Raffle helped out by collecting \$300 more than its cost. We are now using Zeffy to collect dues for next year with about 70 members paid up. Michael had checks and cash for 6 more members' dues so that left ~ 25 members unpaid. We went over the list of unpaid members and board members volunteered to call them. Al said we have 105 members on our rolls that will have to pay to the State Sirs organization.

We are beginning to use Zeffy as our means for signing up for monthly lunches and other events. So far 28 members have signed up for the January 2 lunch and Tom Short showed us how to sign up using the new system. Zeffy requires payment online by credit or debit card with a selection of lunch choice. The deadline for signing up for January 2 is December 30. Only a few members don't have email, but they can be signed up by another member and make payment to that member. Members who bring guests will have to make payment and reservations with Zeffy and be reimbursed for their guests. The choice of meals for the coming year will be the same as previous years (usually a meat dish, salmon or salad). Those who don't make Zeffy reservations will have to take what's ready.

The Valentine lunch on February 6 will include ladies as guests this year. The menu choices will be the same as the Christmas lunch (prime rib, salmon, chicken or pasta). Costs will be probably be \$50 for prime rib and \$40 for the other choices. Reservations and payment will be made online with Zeffy. Ted Pullen will be given access to the sign ups to handle table assignments and Ken Kauer will purchase roses for the ladies. A notice about the Valentine lunch will be sent out to all members in early January.

Kelley Reid will induct 3 new members at the January meeting: David Pell, Irv Schwartz and Zee Skyvara. Marty Rayman sponsored by Bob Bundy was approved for membership. Officers for the coming year will be installed at the January lunch by Dr Bundy. Officers for '25 will b: Big Sir-Tom Verkozen, Little Sir open, Treasurer -Al Wuthnow, Secretary - Dick Robinson and other board members in their continuing positions.

Speakers for the coming months are as follows: Ron Rosano, an astronaut from the Galactica space mission, in January, Jason Balderama from Marin Count IT Security, in February, Michael Dybeck from the Boy Scouts in March and Kent Fortner from Mare Island Brewing in April.

Ted Pullen is working on a group trip to attend the show "Mamma Mia" in San Francisco in May. It would include the bus ride, lunch and the show. He'll work out cost for the package and use Zeffy for signing up.

The Lucky 7 Golf group concluded its season with an award lunch at McInnis on December 17. The 2nd Tuesday book club will be meeting on Tuesday January 7 to discuss the book "Black Raven". The pool group meets on Thursdays following the monthly lunch and Exec Board Mtg.

Ron Rosano is a "graduate" of Richard Branson's Virgin Galactica Space Program. He is Galactica astronaut 017 on Galactica flight 04 which seems to be a culmination of a lifelong interest in astronomy and space flight.

Watching the Apollo Moon landing as a child initiated his interest in space and space travel. He pursued an interest in astronomy with a passion for educating youth about the wonders of space and where our fragile planet fits into the solar system. He has served as an ambassador to public schools where he has brought his enthusiasm for space to thousands of students.

Since 2008 he has given over 70 presentations as a NASA Solar System Ambassador about the Mars Rover, James Webb telescope, moon landings and the possibilities of commercial space flight. As you might expect he has also given many presentations about his own experience on his Galactic 04 space flight. We are fortunate to have him start our 2025 luncheons with his incredible story.
